




Figure 1. DC Current Gain




Figure 3. Input-Off Voltage




Figure 2. Input-On Voltage




Figure 4. Power Derating




Figure 5. 3-LEAD, TO-92, MOLDED 0.200 IN-LINE SPACING LD FORM (J61Z OPTION) (ACTIVE)
